UNFINISHED BUSINESS

- Natural Beauty Status of Engle Rd – The Road Commission held the first public hearing, and will be scheduling a required second hearing. After that hearing, the Commission has 30 days in which to make a decision about whether to remove the Natural Beauty Designation.

NEW BUSINESS

- Township Website – the website has been experiencing problems with displaying meeting minutes and agendas. Lydy spoke with Pixelvine, and we believe the issues have been corrected. The Clerk's office will be working on revamping the website.
- Wolverine Power Cooperative Ordinance – Motion by Lydy, seconded by Stout, to table the topic until more research can be done on Wolverine and Consumers Ordinances. **Motion Passed**
- Planning and Zoning – Bringing Planning & Zoning in-house was discussed. No action taken.
- Election Summary – Stout shared a summary of the November 4, 2025 special election. We mailed 656 absentee ballots, 400 were returned (61%), had 188 in-person voters, turnout was 18%.

PUBLIC INPUT

- Lani Forbes – the Freeport Fire Department hired a second Dept of Public Works employee. Sub-contracted for work on Hammond Road so county maintains all of Hammond. Santa will be at the Freeport Community Center on December 20 from 6-8pm.

BOARD MEMBER COMMENTS

- Nagel – is retiring from her position as Deputy Treasurer with the City of Hastings. Her last day will be December 12, 2025.
